# **Program Overview**

UCalgary Law is committed to preparing their students for practice in the 21<sup>st</sup> century. Through the Innovation Internship Program, forward thinking employers in the legal industry are paired with UCalgary Law students who have an interest and, through the Innovation Internship Training Program, the knowledge and skills to help employers address and overcome key business challenges.

#### Program Outcomes

Through this training program, students will:

- Develop a broad understanding of the complexities of the legal industry in the 21<sup>st</sup> century
- Be able to identify the major issues facing legal service providers including large, mid-size, and small law firms as well as corporate counsel and the courts
- Gain hands on experience in key methodologies used for identifying, developing, and implementing solutions to industry challenges, including: process mapping, stakeholder needs identification, project management, and communication
- Develop a broad understanding of how technology and legal service delivery models are evolving to address industry issues and capitalize on opportunities
- Be able to apply key principles of leadership, project management, and change management to support the transition from ideation to implementation in a legal environment

#### **Program Delivery and Preparation:**

Over the course of three days students will participate in online lectures delivered by industry leading experts and will have an opportunity to apply their learnings in a collaborative case study. Students will present their case study recommendations at the end of the program and receive feedback from a panel of industry leaders.
